

COVID-19 Update for Devens: June 16, 2020



Pop-up COVID-19 testing sites: The State is opening pop-up COVID-19 testing sites for individuals who have recently participated in large gatherings. **These free testing sites will be available at over 50 sites throughout the Commonwealth on Wednesday, June 17th and Thursday, June 18th.** The Administration is urging anyone who has attended a large gathering in the past two weeks to get tested for COVID-19 at one of these sites. Test results will be provided to each participant confidentially, and participants are encouraged to share these results with their doctors. Phase 2 Now Underway: Step One of Phase 2 began on June 8, 2020. Additional businesses may be able to open in Step 2 of Phase 2 at a later date to be determined based on COVID-19 trends and data. Re-open Safely: All businesses re-opening must have a COVID-19 Workplace Safety Program in place and must post a COVID-19 Compliance Attestation Checklist near the entrance to your office, visible to visitors and employees. **You can download a template at:** <https://www.mass.gov/info-details/reopening-massachusetts>. After a prolonged shutdown, building owners and employers should also ensure that their building is safe. 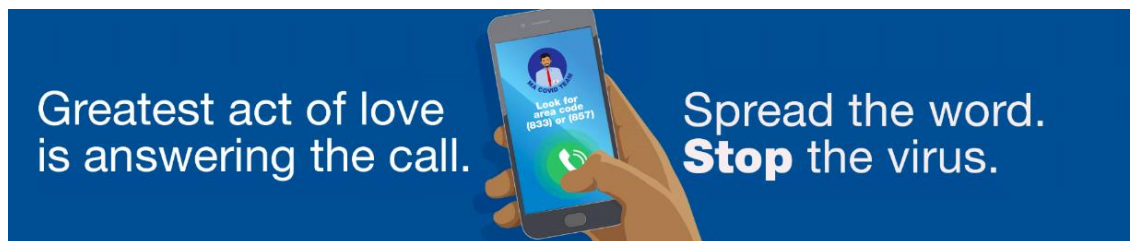
