

## COVID-19 Update for Devens: June 24, 2020



**Step 2 of Phase 2 Now Underway:** On June 22, 2020, Phase 2 Step 2 began and allows for indoor table service at restaurants subject to updated guidelines and workplace safety standards: <https://www.mass.gov/info-details/safety-standards-and-checklist-restaurants#phase-ii-step-2>. Step 2 of Phase 2 also allows for the expansion of Close Contact Personal Services, which are defined as any personal service typically delivered through close physical contact with the customer, including but not limited to:

- a. hair salons and barber shops; as permitted to open in Phase 1 of the Re-Opening Plan (subject to these workplace safety standards for Close Contact Personal Services on June 22, 2020)
- b. hair removal services; including laser services, depilatory salons, waxing services, threading, and electrolysis services
- c. massage, body treatments, eastern treatment, energy therapies and other body work therapies;
- d. skin care services; including peels, facials, serums, Botox and filler
- e. nail care services; including nail salons
- f. other hair services; including hair replacement services, scalp treating services
- g. makeup salons;
- h. makeup application services;
- i. personal trainers; provided that in Phase 2 any indoor personal training service is limited to appointment-only training with only one customer (or two from the same household) allowed in the facility at a time;
- j. tanning salons; including other businesses that provide spray tanning and tanning beds; and
- k. tattoo, piercing, and body art services

- RESTAURANTS** (fork and knife icon): may resume indoor service on a limited basis and in full compliance with social distancing requirements. Tables must be appropriately spaced, parties remain limited to no more than six and patrons cannot be seated at bars.
- NAIL SALONS and other CLOSE CONTACT PERSONAL SERVICES** (nail polish icon): (massage, skincare, etc.) may resume operations under enhanced safety guidelines including 6 ft. separation between workstations and sanitation of space between customers.
- OFFICES** (desk and chair icon): are permitted to increase their occupancy from 25% to 50% of their total capacity. Employers are encouraged to continue to allow their employees to tele-commute or work remotely when possible to avoid unnecessary use of public transit.
- RETAIL STORES** (shopping bag icon): may reopen dressing rooms by appointment only. Stores must continue to require customers to wear facemasks and enforce social distancing guidelines. Capacity limitations in place under phase 2, step 1 remain in place.

**Re-open Safely:** All businesses re-opening must have a COVID-19 Workplace Safety Program in place and must post a COVID-19 Compliance Attestation Checklist near the entrance to your office, visible to visitors and employees. **You can download a template at:** <https://www.mass.gov/info-details/reopening-massachusetts>.
