Dimensions of 50ftx60ft with tables, chairs, and trash/recycling bins inside. Access point with TIPS certified ID checker on the southern wall of fencing. Detail trooper to be present throughout the event. Requesting that children appearing to be under the age of 12 be permitted in with an adult over 21 years old so we do not have unsupervised children throughout the rest of the event space. 21+ adults will be ID'd and get a wristband, children will not.

The outdoor area is to be enclosed by fencing or other barrier set-up for the purpose of restricting the removal of alcoholic beverages by patrons/guests (show on proposed layout plan and include dimensions).
