RE: 2026 Common Victualler and Alcohol License Renewals

Common Victualler License Renewals:

All facilities in Devens that have the capabilities for cooking, preparing, and serving food and which provides seating for the immediate consumption therein, are required to have a Common Victualler License that is renewed on a yearly basis. Common Victualler licenses falls under the DEC's Board of Health responsibilities. All food preparation facilities in Devens are inspected on an annual basis and food service permits are issued by our agent, Nashoba Associated Boards of Health. The following locations have existing licenses and are seeking renewal for 2026:

- 6. Mexican Grill Inc. (Bandoleros) 4 Ryans Way
- 7. Hilton Garden Inn 59 Andrews Parkway*
- 8. Springhill Suites by Marriot 27 Andrews Parkway*
- 9. Devens Common Conference Center 31 Andrews Parkway*
- 10.Red Tail Golf Course 15 Bulge Road
- 11.MPG Corporation (Rapid Refill) 4 Andrews Parkway
- 12.Flik (Commonwealth Fusion Systems) 117 Hospital Road*
- 13.Flik (The Canteen) 65 Jackson Road*
- 14. Sterling Street Brewery 65 Jackson Road*

Recommended Action: There have been no reported violations, safety concerns, or incidents of food-borne illnesses at any of these locations. State Police and the Devens Public Safety Officer have not had any reported incidents at any of these locations. Unless there are any concerns, staff would recommend the Commission make a motion to approve the renewal of the 14 Common Victualler Licenses for 2026 as listed in the December 1, 2025, staff report, subject to issuance of their food service permits by Nashoba Associated Boards of Health.

Alcoholic Beverages License Renewals:

MGL Chapter 498 of the Acts of 1993 section 11 (Powers and Responsibilities of the Commission) 5 (h) as amended, allows the Commission to issue six (6) Alcoholic Beverage Licenses in Devens that are required to be renewed on a yearly basis. All licensed facilities serving alcohol are inspected on an annual basis by our agent, Nashoba Associated Boards of Health, as well as the Devens Fire Department. The following locations in Devens currently have an Alcoholic Beverage License and are seeking renewal for 2026:

- 1. Mexican Grill Inc. (Bandoleros) 4 Ryans Way (All-Alcoholic Beverages License)
- 2. Hilton Garden Inn 59 Andrews Parkway (All-Alcoholic Beverages License)
- 3. Springhill Suites by Marriot 27 Andrews Parkway (Wine and Malt Beverages License)
- 4. Devens Common Conference Center 31 Andrews Parkway (All-Alcoholic Beverages License)
- 5. Red Tail Golf Course 15 Bulge Road (All-Alcoholic Beverages License)
- 6. MPG Corporation (Rapid Refill) 4 Andrews Parkway (Off-Premises/Package Store License for Wine and Malt Beverages)
- 7. Sterling Street Brewery 65 Jackson Road (Farmer Series Pouring Permit)

Recommended Action: All Licensees have provided a copy of their current Fire Safety Inspection Certificate, and the State Police have confirmed that there have been no alcohol-related incidents at any of these facilities over the past year. Health inspections were also performed and there have been no reported violations at any of these locations. State Police and the Devens Public Safety Officer have not had any reported incidents at any of these locations either. Unless there are any concerns, staff would recommend the Commission make a motion to approve the renewal of the six (6) Alcoholic Beverage Licenses and one (1) Pour Permit for 2026 as listed in the December 1, 2025, staff report.
